The meeting was called to order at 6:45 p.m.

Agenda item: Review investment documents including Commitment Letter

for proposed 134 Main Street project.

David Doneski described how the commitment letter references another document, the Memorandum of Understanding (MOU) and that the Trust does not have a final version of that document. Since the MOU sets out critical investment elements such as the Trust's financial stake as a percentage of the whole, David Doneski recommends that the Trust hold the document in reserve if it decides to execute the document this evening.

Josh then reported on a recent conversation he had with David Valletta regarding how the Trust's investment would be handled in the event of litigation. David Valletta suggested that the Trust's investment stay involved during litigation and he also floated the idea of the Trust sharing litigation costs.

Members of the Trust agreed that they would like to meet with Bob France and have all financial questions resolved before executing the commitment letter. Specifically, the trustees want to review the commitment letters for all the other investors and want the MOU finalized and signed.

Stuart moved to approve the October 6, 2011 draft minutes, Colleen seconded and motion carried 5:0.

The next meeting is scheduled for Wednesday, November 9, 2011 at 7 p.m. in Town Hall.

Josh moved to adjourn meeting at 6:55 p.m., Stuart seconded and motion carried 5:0.
