# New Business Executive Session for the Purpose of Litigation

Mr. Boles made a motion at 8:05 P.M. to go into executive session for the purpose of Litigation. A roll call was taken and all in favor.

The board has an ATB case on Jan. 27, 2011 with Mr. & Mrs. Blast of 228 Boston Rd. The counsel for Blast is Alan Hoch. Ms. Swezey stated she did not want to represent the town at this hearing and would prefer to suggest settlement or obtain town counsel. Ms. Evans felt the board has been more than fair with and we have given them abatement for FY 08. We suggested to Mr. Hoch a settlement offer of the FY 2010 value of \$471,400 and it was refused by Blast.

Mr. Boles suggest we obtain permission to use Town Counsel from the Town Manager. Ms. Swezey will ask Mr. Haddad if we can do so.

Mr. Boles also suggested we do an outline for Town Counsel with all that has been done or suggested to Blast to date. He also asked to have TC file a notice of appearance and ask if they intend to have an appraisal, expert witness, and TC to answer responses to Hoch. Tell TC of the offer we made and were refused as well as a list of questions for Hoch to address to us.

Mr. Boles made a motion to end executive session at 8:35 P.M. and go back to the regular meeting, seconded by Ms. Evans, all in favor.
