Chairman Fleischer called the meeting to order at 7:00 p.m.

GROTON COMMUNITY SCHOOL – SDS DISCUSSION

John Amaral presented, on behalf of the Groton Community School. Mr. Amaral said construction on an expansion is scheduled to begin at the end of this school year, and confirmed the school will hook up to town water and sewer at that time. It was agreed that annual Title 5 inspections will continue until connection to town water and sewer is made.

214 LOST LAKE DRIVE - NON-COMPLIANCE DISCUSSION

Donald Black presented on behalf of John Scira. Mr. Grossman said the owner, John Scira, has not complied with the order dated, August 17, 2017.

Mr. Black said that on September 30, 2017, the home owner and tenant came to an agreement in housing court that the tenant would move out prior to November 1, 2017. Mr. Black confirmed the tenant moved out and work has begun to comply with the order. Mr. Black made note that he's here to keep peace between Mr. Scira and the Board of Health. Mr. Black presented the Board with a notarized limited power of attorney granting Donald Black permission to speak on John Scira's behalf regarding all Board of Health matters related to the property at 214 Lost Lake Drive.

A discussion ensued about the violation 410.401 ceiling height. Jason Weber explained that a variance would be required and suggested the request be submitted in writing. It was confirmed that a Condemnation Hearing will be held on Monday, November 20, 2017, at 7:00 p.m.

5 BABY BEACH ROAD - SDS VARIANCE REQUEST DISCUSSION

John Hyland was present. Ira Grossman confirmed the property does not have a potable water supply and thus the property is not a habitable dwelling. Mr. Grossman said Title 5 does allow seasonal camps to use tight tanks. Mr. Grossman said he was not sure a tight tank would fit on the property. A discussion ensued about possible variances and the use of a tight tank.
