• 1 water quality test done, reinspection not done

- Yes, board would like second water quality test given timing is not a concern
- Don asked about timing of 2<sup>nd</sup> water test
- Don asked about legal filing because it was rejected by local attorney's office as insufficient
  - Was looking for a special permit
- Will setup a time on WE for the reinspection
- Motion
  - o Continue to next meeting
  - o If all requirements met, Ira will close it out on behalf of the board
  - o Ira is empowered to sign habitability document on behalf of board
- JW moved to continue, Susan 2nd; all ayes

7:13 – Ira is expecting the parties for 149 because he has not heard from them since their last conversation.

## 7:25 -149 Whitman Rd

- Ira: nothing since we met on it
  - o SDS is 53 years old
  - o Property owners claim it's a 1K gal tank
  - o Nitrates were 13mg /liter
  - o Less than 100 ft from well & septic
  - o Nitrate limits are 5mg /liter
  - Additional problem with nitrates > 10 is a double whammy, well is not a safe source of drinking water
- Robert: is there a proposed solution? Ira: the proposal was for reverse osmosis. The septic
  is failing, the well is also failing. Because the lot of large, could fix both, I recommend
  doing both
- Ira: The property owner did not want to do both
- Susan: did it get sold? Ira: don't know. Sale could go forward knowing buyer has to fix it
- Ira: Don't think this is protective of health & safety given wat we know

- Bob: I think it's a fail
- Discussion re: whether to invite them again or vote now. This was that opportunity.
- Jason: Based on info from Ira and lack of participation from property owner, I move that
  we recognize the septic system as failing because it is not protective of the public health.
  The Board also notes that the nitrate level in the well exceeds drinking water standards
  for nitrates. Susan 2<sup>nd</sup>; 3 ayes
- Ira to work with Robin to get a written note out
