- Discussion of TLT response to concerns expressed by the Building Committee
 - The Building Committee had concerns about TLT Construction's performance on recent projects. Informal and formal inquiries to recent project owners resulted in the Town asking TLT for considerations before awarding the contract:
 - Letter of support and involvement from TLT's President
 - A list of 3 project teams for the Town to vet
 - Assurance that the same project team will be available to complete the project
 - Identification of a backup project
 - The proposed project team of Thrornton/Rice was not acceptable to the Town. TLT had only submitted the one team for consideration.
 - The Committee would like to tie milestone schedule to the contract

Mark,

As requested, ACG continued to interview several additional people in regards to the resumes of the proposed Project Manager "Butch Thornton" and Superintendent Peter Rice "for TLT.

We had two employees spend two full days searching the internet, making phone calls, and interviewing several references provided. Many phone calls remain unanswered.

At this point in time, we would much rather have discovered favorable results to report. All reports alluded to the same issue. Poor management skills, lack of concern over problem solving, poor planning and purchasing, missed milestones, lack of sufficient interaction with subs, all leading to schedule failure.

We did speak with the two candidates, and did hear what we expected from them. They sounded knowledgeable and experienced.

Based on all of the research we have done and provided to you, it is our opinion that TLT is capable of doing the work, would no doubt complete the project, provide good workmanship by almost all accounts, but also, would not be reliable, responsive, or able to guaranty your scheduled completion date.

Additionally, the negative reports of other OPM and Architect firms highlighted their less than desirable experiences causing additional work for project team members in executing contract administration. We believe you should expect no better results on your project.



Dear Mr. Haddad:

As per our discussion we understand the team of Butch Thornton and Peter Rice has not been accepted. Although we disagree with this decision we will attempt to shift other assignments to provide a different management team. On a project like this, the focus of the Project Manager and Superintendent must be an unwavering commitment to safety, communication, budget and schedule. We will put proper systems in place and a project team that has the necessary skill sets to mandate focus on the project goals. The salient skill sets required to accomplish the stated goals are devotion to details, willingness to identify conflicts early, and the dedication to force resolution of issues timely.

No person on our staff has this set of skills more than Bob Garside who is currently working at our sister company, Endicott Constructors Corp. We will make arrangements to move him over to TLT Construction Corp.

Bob Garside - Project Manager

Bob has been with us for 3 years. He was responsible as Project Manager for two (2) projects at the Newport Naval Station with the Naval Facilities Command. He successfully completed both projects and since completion he has been working in the office on multiple projects creating and updating the project schedule and working on various submittal logs. Bob has vast experience in the Government sector and has completed many projects as the project manager with the U.S. Corps of Engineers.

- This experience requires discipline and attention to detail since, working with NAVFAC and USACE, one must be able to maintain and follow a system set up for an individual project under the strict guidelines established by the USACE. We want Bob to bring these systems to the Groton Project and implement a three-phase system on inspections that will provide a great benefit to the project.
 - 1. The three-phase system of control begins with a pre-work meeting with each subcontractor for every definable feature of work. The pre-work meeting is designed to make sure all questions are identified early, that there is a complete understanding of the scope of work required and that the subcontractor commits to the project schedule requirements and specific milestones.
 - 2. Once work begins, on or about the first day, the superintendent or other inspector will review the work put in place and confirm all procedures put in place by the subcontractors are in accordance with the pre-work meeting and or the specifications. If not, a deficiency will be noted and entered on a log. Multiple inspections will occur during the performance of the work to confirm the work is in conformance.
 - 3. The third phase of the inspection is the follow-up inspection for each deficiency listed. This phase is continuous until each deficiency is taken off the list.



We have attached a draft plan for the Groton Project and believe the involvement of ACG in this project will be a great benefit. As per our meeting, Michael Josefek indicated ACG was willing to assist in identifying the potential conflicts early in the process to prevent later impacts. Their involvement in the pre-work meetings would be of great benefit to the project and give them a forum to assist us in identification of potential issues, as well as assist in the required communication so the Owner's representative and the contractor are on the same page with respect to the planned work, duration and flow.

The following is a description of each of the projects completed in Newport and the contact information for each.

- Newport Naval Building 302

 - Value: \$1,800,000. Complete exterior rehabilitation of 30,000sf historic NAPS gymnasium including removal of asbestos and lead painted windows, and replacement of same per Historical Commission standards. Removal of 18,000sf lead painted siding and complete replacement of sheathing and new cedar siding. Removal and replacement of barrel vaulted roof and rehabilitation of 32 exterior steel covered wood laminated beam structures.
- ➤ Newport Naval Building 656
 - Contact: Martin Kawa, Civilian QA Specialist: (401) 841-1569
 - Value: \$2,300,000. Complete exterior rehabilitation of Base MWR Center including removal and replacement of brick façade with new EIFS, removal of asbestos caulking on existing corrugated roof, and installation of rubberized spray applied roofing system. Installation of blast-resistant storefront and windows at Officers Club. Project also contained removal of asbestos covered underground steam pipe, installation of 300lf of insulated underground steam line work, and new controls in Mechanical room.


Steve Viegas - Superintendent

- The Manchester-by-the-Sea project is much larger and more detailed than the Groton project, but both projects require the same skill set and attention to detail.
- Steve's engineering background and experience will be an asset to this project and will allow him to use this skill set through the concrete portion of the project.

Tom Kostinden - Project Executive

I will handle this project myself. I will be an active Project Executive and meet with Bob Garside each week to help direct the daily activities. I will attend one (1) site meeting per month and visit the site as needed. We have experienced success when we schedule a formal principal meeting at least each quarter so each one of the stakeholders have an opportunity to discuss any issues. This format is also the last level of dispute resolution



where anyone of the principals may bring up an issue that requires resolution; an action plan is put in place at this meeting and tracked.

We have attached the other available teams, but believe the Bob Garside/ Steve Viegas team with the oversight of Tom Kostinden on the Groton Project is a successful team.

- Butch Thornton and Peter Rice is a good fit for the Groton Project.
- John Galasso and Steve Gauthier along with Bob Zuccalmaglio were the original team scheduled for this project. They are obviously still available.




