Approximately 30% of the Groton Historical Society's collection is curently housed on the third floor of the Boutwell House. The objects are subject to deterioration due to ever-increasing summer heat in the rooms. The Society has no altenative space on the property to store the items and are therefore seeking funding to improve attic conditions to the point where the collection can be stabilized.

The proposed project will remove all collection items for cleaning, minor conservation and cataloging by trained interns followed by short-term secure storage. Once the collection is in temporary storage the rooms will have walls and ceilings repaired to create a stable, maintainable environment. Addiitonal work will include the installation of storage shelving and mechanical ventilation to reduce extreme summer heat levels. The proposed work will assure proper storage and protection of these significant artifacts from Groton's past for future generations.

As Vice-President of The Footwork & Frolick Society, I am delighted to write this letter in support of The Groton Historical Society's application for community preservation funds.

The Footwork & Frolick Society (F&F) has benefited from a close relationship with The Groton Historical Society (GHS) and Boutwell House since 2022, when our organization was established. During that time, the F&F mission to "promote historical education through the research, recreation, performance, and instruction of eighteenth and nineteenth century dance and other active pursuits rooted in the social traditions of the American Northeast" has been greatly enhanced by a number of collaborations with the GHS. For example, F&F brought the Boutwell House's interior spaces to life by wearing nineteenth century style clothing while engaging the public in period parlor games during Boutwell House's annual spring open house as well as teaching and performing nineteenth century dancing during their open house for the winter Grotonfest events. In addition, F&F hosted our first fundraiser, a sumptuous Victorian style tea, at the Boutwell House in 2024. Well preserved objects are windows into the past, providing opportunities for modern individuals to explore new perspectives and gain new information. In that way, the Boutwell House itself and its objects have helped the GHS to fulfill their mission of engaging with the public and being a repository of historical information and a museum. Additional funding for renovations and the installation of climate controlled spaces would only serve to improve and support this work.

During my 10 year stint as president of the Groton Historical Society and also as former curator—and still active member—of said organization, I was always concerned about the storage and environmental limitations for our collection of historical significance that represents Groton's past. The most likely out-of-the way place to store materials not on display has historically been in the attic. Over the years of my tenure, there have been weather-related events that jeopardized the many documents, textiles, paintings, and rare books and these are still currently exposed to potential roof damage/leakage and temperature extremes as well as residing in existing overcrowded conditions.

Boutwell House, as the home of the historical society, has the ability to display elements of its collection and share this history with the greater community while at the same time has the responsibility to curate and protect the contents of its current collection and be open to the possibility for future acquisitions that always seem to turn up.
