
### Addendum to CPA application FY 2022-06 Squannacook River Rail Trail

- 1. Funding request, \$30,000, is limited the amount needed to complete the project by augmenting a DCR MassTrails grant of \$100,000.
- 2. Project title has been changed to 'Squannacook River Rail Trail Crosswinds Drive to Bertozzi WMA' (Wildlife Management Area)
- 3. Management of the SRRT is by the applicant, Squannacook Greenways. Squannacook Greenways has the experience from the work that been performed on the SRRT to date which includes all requisite permitting, clearing of the rail corridor and final construction on Townsend sections of the trail. S.G. will also liaison with the CPC, coordinate with contractors, ensure timelines are adhered to, verify work is completed per contract specifications, and ensure invoices are verified and signed before submission to the CPC for final approval and subsequent payment.

An RFP for bids will be sought Fall, 2021. Squannacook Greenways has engaged in the RFP process for the current construction in Townsend and is using the bid numbers that were awarded for that section as a hard number for this CPA application.

Once the trail is constructed, Squannacook Greenways will be responsible for future maintenance and upkeep, as well as outreach and promotion. Our finances include an operations budget of \$2,000/year, with \$1,500 for insurance and \$500 for materials. These numbers were developed in consultation with Wachusett Greenways, who have been maintaining a similar rail trail for over 20 years using only volunteers. All ongoing maintenance work will be performed by Squannacook Greenways and our volunteers. Our group has been committed to this project for almost 15 years, and we will continue our commitment for the future of the trail.

- 4. A map of the Cosswinds to Bertozzi section has been submitted electronically.
- 5. Additional funding source will be a DCR MassTrails grant. Also volunteer labor has been used extensively and will continue to be used in trail maintenance and clearing. Professional engineering services have been donated and were used in the final design documents.
- 6. The CPA pdf application previously submitted has been updated and resubmitted to incorporate requested updates. Due to the nature of the format, it is unclear if all changes made it into the updated application.

Dear Community Preservation Committee:

At their 19 January 2021 meeting, the Groton Trails Committee unanimously voted their support for the Squannacook Greenway's application requesting \$30,000 from Groton's Community Preservation Act (CPA) funds.

The Squannacook River Rail Trail (SRRT) will go from the Squannacook River Wildlife Management Area (WMA) in Groton to downtown Townsend. The SRRT is being built in three phases and this Project 2022-06 represents part of the funding for the third phase. The third phase will build 0.65 miles of the trail that is entirely within the bounds of Groton. The bulk of the funding for this third phase will be sought by the Squannacook Greenway organization from the state's MassTrails grant program, which requires a 20% match. The \$30,000 will be used to pay the match as well as other estimated expenses that will exceed the ceiling of the MassTrails grants.

The Groton Trails Committee supports this project because it will create a) Groton's only trail connection with Townsend; b) a much-needed additional accessible trail in Groton; c) a larger recreational destination comprising the SRRT, the Bertozzi Conservation Area, and the Squannacook River WMA; and d) an alternative to using the busy Townsend Rd. for reaching those recreational opportunities from homes in Townsend, the Crosswinds subdivision, and nearby on Townsend Rd.

On January 12, 2021 the Conservation Commission reviewed a request from the Squannacook Greenways regarding the FY22 CPA application — the Squannacook River Rail Trail (SRRT). The Commission voted at this meeting by roll call vote to voice its support of the application for funds to complete the Groton portion of the SRRT from the Bertozzi Wildlife Management Area to the northern Crosswinds Drive crossing for a total distance of .65 miles. The \$30,000 being requested by Squannacook Greenways will serve as the local match for a \$100,000 Department of Conservation & Recreation (DCR) MassTrails grant. Squannacook Greenways has successfully used this approach in development of the SRRT to date in Townsend where the final phase of construction is underway now between Townsend center and the Townsend harbor area. In Groton, the entire rail corridor has been cleared of trees and the rails have been removed. The final phase will involve removal of the old RR ties, grading of the base and the application of a final stone dust surface.

Development of the SRRT has been underway for a number of years and was subject of a previous CPA grant: # 2007-11; SRRT Environmental and Engineering Assessment which this Commission enthusiastically supported. The benefits of development of the SRRT have been identified both in the Town of Groton's Master Plan as well as its Open Space and Recreation Plan. The advantages of trails that provide a non-motorized source of recreational activity to the community have long been recognized as one of the greatest assets Groton has to offer its residents. And our town's experience with the Nashua River Rail Trail is a prime example of this fact. This has become even more evident over the past year as the impact of the COVID pandemic has led townspeople to explore safe ways to be outside and appreciate the open space our town has to offer.

The Nashua River Watershed Association (NRWA) writes you in support of Squannacook Greenways, Inc. (SGI) application for funds to complete work on .65 miles of the Squannacook River Rail Trail (SRRT) in its Groton portion, that is from the Peter E. Bertozzi Conservation Area to the northern Crosswinds Drive crossing. SGI requests \$30,000 which is the amount needed as local match for a Department of Conservation and Recreation "MassTrails" grant of \$100,000.
