Minutes: Minutes from the July 13 meeting were presented by Helen. They were reviewed and a motion to accept was made by Paula, 2nd by Therese. All unanimous approval accepted.

The Groton Connects initiative has a new sign over Main Street. It is an opportunity to address loneliness. There will be upcoming ideas for us to connect with people around us and to help with anyone's loneliness. Kathy hopes to get some mailings out to residents throughout the coming year.

Therese brought up the question of suicide. Dorothy also spoke of her concerns. Paula mentioned the showing of the film "13" that was shown last week. Kathy asked all of us to speak up about any thoughts and ideas about dealing with this issue. Mihran asked if Marlena and the school department be included in this program.

Outreach Report There will be copies of the two pamphlets on elder abuse issues for us to review. Stacey also mentioned that

there are interesting videos for people to watch concerning this problem.

Activities/Volunteer Report: The "911" and Drive-In events were both successful. The Meals On Wheels driver amount has increased from 3 to 12 drivers. Therese asked if many people are playing billiards. It has increased. We are in need of a vice-chair person.

Peter mentioned the Town Meeting on October 3. We have an article concerning an assessment on the Sportsman's Club building. Mihran told us about our meeting a few Sunday's ago with Larayne Black.
