6:00 P.M. Chairman Bud Robertson called the meeting to order.

### **RESERVE FUND TRANSFER REQUESTS:**

Country Club Generator: Mr. Campbell explained that he prefers to operate with 3 working pool heaters during the season. One failed a couple of years ago, and due to lack of funds, the Club has been running with only 2. Two weeks ago, one of the remaining heaters caught fire due to an undetected mouse nest inside the system. With only a single heater, the pool can only be heated to about 70 degrees; the Club patrons are most comfortable at 80 degrees. Mr. Sulprizio asked about the life expectancy of these units and whether there was any need to replace the 3<sup>rd</sup> heater now along with the other 2. Mr. Campbell believes the heater that is still running has some life left in it. Going forward, they will do a comprehensive analysis of the condition of each system (to ensure that no mice are present) before starting them up each season. Mr. Sulprizio warned that even a small amount of current running to the heater when it is shut off will create a warm environment that will attract rodents.

On a motion by Mr. Manugian, seconded by Mr. Whitefield, the Finance Committee voted unanimously to approve a Reserve Fund Transfer to Country Club Expenses for FY22 in the amount of \$14,000. Roll Call Vote: Mr. Doody – Aye, Mr. Manugian – Aye, Mr. Green – Aye, Mr. Whitefield – Aye, Mr. Robertson- Aye, Mr. Sulprizio - Aye (The Vote: 6-0-0)

Police Department Generator: Chief Luth explained that the generator project was approved two years ago and funded with a Reserve Fund Transfer in the amount of \$24,000. Unfortunately, the project was delayed, and the funds were allowed to return to Free Cash at the end of FY21. The generator project is now complete with a minor cost overrun of \$6,451 (due to the costs of a mandated load test and

replacement of some additional defective equipment). This request would simply re-establish the funding that had been approved before the project was delayed.

On a motion by Mr. Manugian, seconded by Mr. Whitefield, the Finance Committee voted unanimously to approve a Reserve Fund Transfer to FY22 Police Expenses in the amount of \$31,451.10. Roll Call Vote: Mr. Doody – Aye, Mr. Manugian – Aye, Mr. Green – Aye, Mr. Whitefield – Aye, Mr. Robertson- Aye, Mr. Sulprizio – Aye (The Vote: 6-0-0)

### **Human Resources Recruitment Costs:**

Ms. Dufresne explained that due to excessive recruitment costs (advertising, background checks, physical exams), the H.R. Expense line for FY22 will need support in the amount of \$7,000. The Town Clerk position in particular will be expensive to fill (as it is a key position and will be advertised more widely than others).

On a motion by Mr. Manugian, seconded by Mr. Whitefield, the Finance Committee voted unanimously to approve a Reserve Fund Transfer to FY22 Human Resource Expenses in the amount of \$7,000.
