# **Groton Greenway Committee**

Meeting Minutes

Date: November 26, 2012

Location: Town Hall, 2nd Floor Kitchen, 173 Main Street, Groton, MA

Time: 7 p.m.

Members Present: Carol Coutrier, Fran Stanley (arrived late), Marion Stoddart, Adam Burnett, David Pitkin Other Attendees: David Manugian, Jack Petropoulos (Selectman), Pierre Comtois (Nashoba Publishing)

David Manugian led the meeting but for input from chair Marion Stoddart on approval of November 16<sup>th</sup> minutes. David M. will inquire with Town Manager about appointing separate Fitch's Bridge Committee, but the work can continue since all Greenway members are satisfied with David Manugian's leadership on this matter despite the fact that he is no longer a member of Groton Greenway Committee.

David Manugian estimated that the engineering consultant, FST, may have its initial cost estimates in the second week of December. FST will attend the December 18 meeting and can speak to important technical questions such as explaining why the Town should stabilize abutments after removing the current bridge.

Adam Burnett reported on a conversation with Ray Ciemney regarding salvage and re-use of decorative bridge materials. According to Ray, the rosettes are less distinctive than the initial truss opening. If the construction crew can set aside this portion of the bridge, Ray will remove separate it with a blow torch. Then, he could fashion a decorative portal – similar concept to the FST design proposal but superior in that it re-uses a portion of the old bridge. Ray will not work on bridge while it is intact and in place over the river. David Manugian will take this generous proposal from Ray Ciemney under advisement to see it can be incorporated in the final construction contract. All Greenway members approved of the concept and expressed thanks to Ray Ciemney for his generous offer.

Here is a copy of the motion from November 3<sup>rd</sup> Town Meeting that secured the \$95,000 in engineering and design funds:

"MOTION: I move that the sum of \$95,000 be transferred from the Stabilization Fund for all professional design services, including surveying, engineering and permitting, related to the construction and/or removal of a new pedestrian, equestrian and bicycle (non-vehicular) bridge over the Nashua River at the location of the current Fitch's Bridge that will connect Fitch's Bridge Road and Pepperell Road."

The group discussed the warrant articles and how to plan the Fitch's Bridge presentation before Town Meeting. Jack Petropoulos suggested that the Greenway make a recommendation to the Board of Selectmen. David Manugian will communicate the group's consensus opinion that is recommends a single presentation at Town Meeting with whatever number of articles would be required so long as Town Meeting voters get a chance to decide both matters – replacement and/or demolition and stabilization in a single Town Meeting.

The cost of the replacement bridge may be the best determinate of the order of the warrant articles. David Pitkin explained that an incremental cost for replacement bridge might suggest putting vote for replacement second whereas an investment level of cost for the replacement bridge might suggest scheduling the replacement cost first.

Conversation turned to efforts by the Greenway to alert the public to the upcoming warrant articles and explain the benefits of replacing the bridge. Marion outlined her suggested public outreach. The group agreed that ideally there should be weekly outreach to the public in each of the 8 weeks before Town Meeting with informational articles, letters to the editor, editorials, postcards to Town residents, cable access shows, and electronic methods.
