Upon a motion by Marion Stoddart, seconded by Carol Coutrier, it was

 - B. Jean Niemoller will be contacted
 - C. .Marion contacted the town clerk to see if there was anything in the Charter to prevent us from having 7 members instead of 5. The town manager would need to be contacted and we would need to explain to him why we would need 7 members.
 - D. A discussion on this issue ensued:

 - 2. David will focus on the River Festival.
 - 3. David will continue the treasurer side of things.
 - 4. We will leave the number on the committee to 5.

- II. River Festival

- III. 207 Gratuity Rd. Property
 - A. Marion spoke with Bob Pine and others.

- B. Marion spoke with assessors office and found that the property price is down to \$613,000.
- C. Fish and Wildlife is not interested in the property.
- D. Groton Conservation Trust may be interested in buying the whole property and then selling the house.
- E. David: GCT would need to do fundraising campaign in order to be able to do this.
- IV. Fitch's Bridge
 - A. Adam offered to remove the barriers on Fitch's Bridge with permission from the highway department.

- I. Marion: Nashua River Watershed Association is forming a new Greenway Committee for all the areas along the greenway. Watershed Association will appoint some of their directors to be on the committee. The Marion Stoddart Greenway fund will be used to assist in acquisition of land.
