## Groton Greenway Committee Open Session Minutes, 11.7.18, 7:00 PM Town Hall

- IV. River Festival and Ideas for Encouraging Interest in the River
  - A. Adam reported that the banner for the River Festival will be put up on Main St. the week before the River Festival.
  - B. Adam will check with David Pitkin and Pete Carson to confirm the date of June 9 for the next River Festival, 2019
  - C. A review of last year's River Festival will be done at the next meeting when David Pitkin is present.
  - D. Carole Greenfield suggested some ideas for encouraging interest in the river, such as an event with the Watershed Association inviting people to tell stories about the river. She also suggested the need to identify landowners along the river for when parcels come up for sale.
- V. Nod Road

A. Adam will contact the conservation agent by Friday, Nov. 9, 2018 regarding setting up a meeting to discuss Nod Road and the Open Space Plan as well as our mission to make the Nod Road area a functional piece of ground, such as an area for nesting ground birds.

He will share concerns about the area, the history of the area and what has been documented to date, possible next steps.
