The Virtual Meeting was called to order by James Gmeiner at 2:00 PM

797 Boston Road - Sewer Capacity

Ms. Robbins said the proposed plan is for a 24 Unit -Age Restricted Development and it is 100% within regulations for 55 and over. Ms. Enright said due to the pickle ball proposal being defeated, they are proposing a two-building property with (12) 2-Bedroom units and (12) 1-bed units and the parcel is just under 3-acres. Ms. Robbins pointed out that the Town Manager thought this would be a great site for this project and she estimated needing 3,120/gpd. Ms. Robbins said she understands if -they get approved for the capacity requested, they would have to go back to Town Meeting. She said that Mr. Grossman has approved the designed septic and suggested we have the town sewer option approved. Ms. Enright said this is a nitrogen sensitive area and connecting to the town sewer would be a better option.

Mr. Gmeiner said this parcel is not in the district and was intentionally left out because the grant was for mixed business and mixed housing. He also said the BOSC recently voted to eliminate the extension of the district. This was due to the approved amount of the interbasin and we cannot go back to Ayer for more capacity. He said there is some extra capacity set aside, but that would take away from other parcels in the district.

Mr. Orcutt asked what was the break out for the project and Ms. Enwright said (12) 2-Bedrooms @ 150/gpd and (12) 1-Bedrooms @ 110/gpd. Mr. Orcutt said we did vote a restriction a few months ago, but that was more for the Center Sewer District and capacity allotment with Pepperell. He said we did relinquish some back to the State with the interbasin transfer so we do have a limit with Ayer. Therefore, he is not sure we can expand the district to take away from what's in the district.

Mr. Gmeiner told Ms. Robbins they can still take this to town meeting without the BOSC approval. Mr. Orcutt suggested we take a closer look at the numbers and the other parcels not in the nitrogen sensitive zone. Mr. Gmeiner agreed and told Ms. Robbins the BOSC will review and get back to her. Ms. Robbins also mentioned that if this was approved, they could enter into an agreement that is contingent for this project.

Abatement - 217 Main Street

Ms. Crory said she received and abatement request for 217 Main Street, due to an outside water tap leaking and has been fixed. The average quarterly use is 18 units (\$188.55) and they were charged for 53 units (\$896.98). Mr. Orcutt suggested that we bill the sewer units at Tier 1 since they have determined where the leak was and have resolved the issue.

<u>Mr. Orcutt made a motion to abate the sewer charges for the 2nd quarter and bill them at the Tier 1</u> sewer rate for a total of \$469.00 Mr. Gmeiner seconded and the motion passed unanimously. Roll <u>Call: Gmeiner-Aye and Orcutt-Aye</u>
