1 Forge Village

68 Boston Road - Country Butcher

Mr. Gmeiner said they are putting a temporary trailer for storage on site and it will not have any water/sewer use.

Review Sewer Commission Applicants

No Update

797 Boston Road - Sewer Capacity

Mr. Gmeiner said he reviewed the allocation and we currently are using 26,128/gpd out of 40,500/gpd we are allotted.

Mr. Gmeiner was trying to figure what part of NE Power is on the district map and Mr. Orcutt said Lot 1 on Sandy Pond Road and it is zoned for business. Mr. Gmeiner said in the 26,128 we are currently using includes the allocation for NE Power company parcel. Mr. Orcutt said Mr. Rafferty did a potential allocation for Shaw's and that parcel. Mr. Gmeiner said Mr. Rafferty put 12K gpd aside for that. Mr. Orcutt said if we can get 797 Boston Road in the District he is fine with it as long as we are not taking anything away from Shaw's. He feels that this is a parcel that has paid for water connections already and has an allocation set aside for future build out. Mr. Orcutt said if we vote this new parcel in the district, we need to make clear of what the maximum allocation would be.

Mr. Gmeiner said 1,377 gpd is still allocated for Shaw's and we will need to look at this further. Mr. Orcutt said that parcel as well as the 4th or 5th corner are in the Water Resource District and would

require the nitrogen loading issue if they are doing septic. Mr. Gmeiner said we would be over if we do the full allocation they are requesting. Mr. Gmeiner said we are roughly at 39,500 roughly for everything that has been built and what is set aside for the unbuilt. So that would put us 1,000 gpd under our limit and this project would require taking some capacity away from NE Power parcel.

Mr. Gmeiner said we will have to figure out what is left on the Shaw's site and then we will have to decide if we keep stuff earmarked for NE Power. Mr. Orcutt has no problem allocating to the fourth corner, as long as we keep Shaw's whole.
