The Virtual Meeting was called to order by James Gmeiner at 2:00 PM

6 Fairway Drive - Sewer Connection

Mr. Ursprung said his septic was installed in 1966 and with all the rain the tank overflows into the yard and has had to have it pumped and they do not think it would pass inspection. He also said the pipe leading from house to tank is collapsing. He said he did have Mr. Lagasse come out to price out a new system and when walking the property he said his neighbor had a very similar situation. After looking at the property he did not think it was feasible to replace the septic because of the water table. Mr. Lagasse suggested that he reach out to the Sewer Department to discuss this in further detail.

Mr. Gmeiner said he is familiar with the property and the property is not in the district so it would require a Town Meeting vote. Mr. Gmeiner said we will provide the policy and guidelines to review and we will need to have a public hearing to take a position on the proposal to extend the district. Mr. Gmeiner also told them that if you are accepted into the district, it is mandatory that the sewer connection is done.

Mr. Gmeiner said after you think about it, we will need to get an article together for the spring Town Meeting. It would be helpful if you have a Title V inspection showing that it is in failure. We will send you a copy of the Sewer Allocation Policy that shows we are not in favor of extending the district, but since you are in failure it would be considered. Mr. Gmeiner asked that a written estimate of the cost of replacing the system is provided. Mr. Gmeiner also said that since the neighbor did the initial extension more than five years ago, she would not be owed money because she installed the line.

Some other fees included would be the cost of the grinder pump \$5,000.00 est., connection fee of \$7,500.00, inspection fee of \$500.00 and application fee of \$150.00. Mr. Gmeiner said we require the grinder pump installed outside; we do not want installed in the basement.

Mr. Gmeiner asked if the number for Nod Road was added to the Center Sewer budget and Ms. Crory said yes that \$250K pump upgrade and adjusted the transfer for another \$150K.
