The Virtual Meeting was called to order by James Gmeiner at 2:00 PM

### 201 & 227 Boston Road

Mr. Lindemer said he is waiting on the plumbing technicians to get the pressure test done. Mr. Gmeiner said we need a rough as built showing where the line is for our records. Mr. Lindemer said they had a Dig Safe done for the new line and it was mainly done due to the underground utilities coming down the driveway. He said the place where it will tie in at 201has a pipe that is above ground and there is a valve there. Mr. Lindemer told the BOSC that he has not filled out the application yet and was waiting to get all the necessary information. He said he has been trying to line up a grinder pump and Mr. Gmeiner asked where he would be putting it. Mr. Lindemer said it will be outside and they are thinking of using existing septic tank for the location for the grinder pump to avoid having a trench. Mr. Gmeiner asked Mr. Lindemer to reach out to Pepperell for approval to use the septic tank and he thinks it will be ok, but would like their approval. He also asked that Pepperell is onsite for inspections and the pressure test.

Mr. Gmeiner informed Mr. Lindemer of the connection fee for the existing house and Mr. Lindemer is aware of that. Mr. Gmeiner said the Assessors say its 4-bedrooms and a total of 10-rooms. Mr. Lindemer said there is a total of 9-rooms and he said at one point the Assessor's office was charging them for a finished attic that was not finished. He said if they count the kitchen that would be 10-rooms. Mr. Gmeiner said we will base it on a 4-bedroom and asked him to submit the application as soon as he can.
