The Virtual Meeting was called to order by James Gmeiner at 2:00 PM

## **Pepperell**

The BOSC discussed concerns about a proposed standalone emergency room plan, including Paul's comments about the lateral being too close to drainage lines and potential issues with a "doghouse" manhole installation. Paul expressed concerns about the difficulty of correctly installing the manhole, which would involve connecting to an active sewer main, and noted that such installations tend to leak.

They BOSC discussed concerns about a proposed water main connection location, with Paul recommending connecting to a manhole on the west side of Mill-Run Plaza entrance instead of the originally proposed location. This alternative route would avoid issues with ledge, water mains, and the need to use smaller 4-inch house laterals instead of the preferred 6-inch commercial pipe. Paul will attend the next meeting to discuss the engineering aspects of this new connection point.

## FY25 & FY26 Budget

The BOSC discussed financial matters, with Ms. Crory reporting they are doing fine financially and awaiting the certified cash number. Ms. Crory confirmed Pepperell is billing \$52,000 per month as planned. The group discussed an upcoming true-up review in October, and Mr. Gmeiner mentioned plans for Mr. Brinkman to explain how the true-up process works for the IMA.

Other Business: Bills, Minutes, etc.

The group discussed a proposal from Apex to prepare materials for bidding services at Four Corners, which includes reviewing submissions and issuing recommendations. Mr. Gmeiner explained that Apex's role extends beyond just creating the RFQ, as they will manage the bidding process, handle questions, and potentially modify the project timeline based on bidder input.

They reviewed a plan for on-call services and considered the availability of reserves, which is about \$400,000. They decided to proceed with the current engineering firm, Apex, rather than going out to bid for consulting services, as they have a good working relationship and the process would be time-consuming. They also noted that Apex handles both Four Corners and Center Sewer projects, with Center being more extensive due to Pepperell's involvement.

Mr. Gmeiner discussed their long-standing relationship with Apex Engineering, where Mr. Rafferty was the main contact for over 15 years. Despite Bob's departure, the team decided to continue working with Apex, as Mr. Schimdt is now the main contact and is handling the water PFAS project.

Mr. Berg made a motion to approve the proposal from Apex for engineering services for Four Corners Mr. Budry's seconded and the motion passed unanimously. Roll Call: *Gmeiner–Aye, Berg – Aye and Budrys-Aye*
