Grinder Pumps

Pepperell

Mr. Gmeiner asked if we received the monthly Pepperell bill showing the flows. He said with the significant rain event in June we should see a spike and that would illustrate the Inflow that we get. Mr. Berg explained to Mr. Easom that we are trying to get Pepperell to address the inflow and infiltration. Mr. Gmeiner said we do not have a severe issue, but there are clearly a few places that have spikes.

Mr. Gmeiner said we are allowed to send 275K gpd to Pepperell and when its dry we run about 140K gpd and when its wet it creeps up to 160K gpd. Mr. Gmeiner told the BOSC that Mr. Brinkman will be at the next meeting and we can discuss along with the Verizon issue at Nod Road/Partridgeberry Woods.

Ms. Crory will prepare a final budget review for FY27 after all year end bills are received.
