**Continued Public Hearing 8-10 Hollis St Veterinary Health Care –  
Art & Claire Thomas - Directional Signage**

**Chair Peter Benedict read the Public Hearing Notice into the record**

In accordance with the provisions of Massachusetts General Laws, Chapter 40C, the Groton Historic Districts Commission (GHDC) will hold a Public Hearing on **Tuesday, October 23, 2018 at 7:45 p.m. at Town Hall**, 173 Main Street, Groton, MA to consider the application submitted by 2-8 Hollis Street, LLC, Art and Claire Thomas for a Certificate of Appropriateness for replacement of existing directional sign 36" x 18" with white lettering and graphics at 10 Hollis Street with similar sign, with updated company logo. New sign will be same size and colors with new logo mounted in same location as previous logo at 10 Hollis Street. Art and Claire Thomas 8-10 Hollis Street, Groton, MA. **Assessors Map 112-136**. Copies of the application and supporting materials are available for review by contacting the GHDC via the Land Use Department, 2<sup>nd</sup> floor of Town Hall.

Art and Claire Thomas communicated to the Commission that they researched other lighting in the district and would like to change the lighting posed on business sign for Veterinary Health Care approved at their last meeting to the same lighting as used by The Groton Inn. The Thomas's provided photos and a spec sheet of the "new" proposed lighting.

The HDC was fine with the change.

The Thomas' reviewed mock-ups of the proposed enter, exit and customer parking signs intended to be used as directional signs at the Hollis Street business site. The posts will be white standard posts.

The signs will be white with blue lettering in sync with the business signage installed on 1.5 to 2.0-inch round posts. Laura Moore seconded the motion. The motion passed 5 to 0.**

**Public Hearing 195 Main Street – Transformations Medical Weight Loss and Aesthetics**

**Theresa Piotrowski – Business Sign**

**Chair Peter Benedict read the Public Hearing Notice into the record**

In accordance with the provisions of Massachusetts General Laws, Chapter 40C, the Groton Historic Districts Commission (GHDC) will hold a Public Hearing on **Tuesday, December 18, 2018 at 7:45 pm at Town Hall**, 173 Main Street, Groton, to consider the application submitted by Theresa Piotrowski, Transformations Medical Weight Loss and Aesthetics for a Certificate of Appropriateness for a new business sign to be installed at **195 Main Street, Groton, MA 01450**. The sign is proposed to be 2x3 feet, two sided, with colors matching brand colors, white and light green with black lettering, along with a possible silver top and bottom cap. The sign is proposed to be installed on a black bracket in between central windows on second story. The material for the sign will be MDO Sign Board or Sign Foam<sup>4</sup>. Property owner: Federal Investment Trust 200 Great Road, Suite 253, Bedford, MA 01730. Copies of the application and supporting materials are available for review by contacting the GHDC via the Land Use Department, 2<sup>nd</sup> floor of Town Hall.

Janine Doucette LaValley, Broadmeadow Sign Studio, hired by Theresa Piotrowski, Transformations Medical Weight Loss and Aesthetics to make business sign, reviewed the mock-up of the proposed sign with the Commission. The sign will be a hanging two-sided sign, on a black bracket, hung on the second floor in between the windows, attached by black chains. The vinyl lettering will be white stating the business, doctor's name and phone number. The size is 24" x 36" oval shaped sign with a leaf logo centered at the top. Janine also provided a mock-up of the building/location with the sign photo-shopped into the picture.

#### **HDC Comments and Questions**

The placement of the sign is good. Much better than flat on the building front.

Do the dimensions meet the regulations? *Yes, 6sqft is the sign size regulation*

What door/entrance is used? *The center door has the number "195" on it,*

Is the blue darker or lighter? *Darker closest to the larger mock up*

What kind of lighting? *Looking into solar lights*

## Hearing Closed

**George Wheatley made a motion to grant a certificate of appropriateness to Transformations Medical Weight Loss and Aesthetic, Theresa Piotrowski 195 Main Street for a new business sign. The sign will be 2x3feet, two sided, with colors matching brand colors, light blue background with white vinyl lettering, with a leaf logo centered at top with silver edges. The sign will be on a 40 in black bracket with matching chains holding the sign, mounted on the second floor centered between the windows. Laura Moore seconded the motion. The motion passed 5 to 0.**

Janine Doucette LaValley asked the Commission to be allowed to express concerns she has with the Historic Districts signage overall. She stated that she would like to see the HDC take an inventory of the signs in the districts and start a sign program with the businesses/businesses owners in order to bring the signs into compliance and change signs where needed. She believes many signs at one small location should be avoided. One panel stand for signs is better than multiple signs. Janine shared a mockup of how 195 Main Street would look if each of the 3 businesses had a sign above their entrance/window vs the look of today with the individual post signs. Janine would be happy to work with the Town on such a program. She also has concerns about the permitting and inspecting policy and procedures regarding signs.

Carolyn Perkins stated that the Town has a Sign Committee and the Planning Board approved all new business signs in the Town. She suggested that the HDC and Planning Board meet to discuss Town signs.
