She also told the Board that most likely it would not affect the tenant's rent share because the Executive Director told her that elderly tenants over 62 years of age can make up to \$9,360.00 per year in a job that is excluded from total countable income. All Board Members were supportive of Ms. Todd's decision to hire the tenant.
