MEETING OPENED: Mr. Black opened the meeting at 7:03pm.

READING OF THE MINUTES: Minutes for the March 14th meeting were read. They were unanimously approved with amendments.

 Anne McGinty requested April 6<sup>th</sup> at the Town Field for the playground and gazebo area from 11am to 3pm.

- Lawrence Academy requested the Town Field baseball fields for April 3<sup>rd</sup> to May 31<sup>st</sup>, Monday to Friday from 3:30-5:30.
- Groton-Dunstable Youth Football requested the Cow Pond football and practice field for:
  - o June 17<sup>th</sup> to June 23<sup>rd</sup>, Monday-Saturday from 8am to 8pm
  - o July 23<sup>rd</sup> to July 28<sup>th</sup>, Monday-Saturday from 8am to 8pm
  - o July 30<sup>th</sup> to December 1<sup>st</sup>, Monday-Sunday from 8am to 8pm
- Groton Youth Baseball requested the:
  - Town Field baseball fields for April through August, Monday-Friday from 5pm to
     8pm and Saturdays and Sundays from 8am to 8pm
  - o Cow Pond fields #1,2,3, and 4 for the same times as the Town Field
  - o And Cutler Field for April through August, Monday-Friday from 5pm to 8pm
- All requests were approved.

#### **REPORTS**:

- Ryan Hamerla gave an update on his proposed Eagle Scout project to create a boulder memorial for Sgt. William Woitowicz at Stonebridge Field. He plans to start the work in mid-June and end by early July. A site walk will be done on Saturday, April 28<sup>th</sup> by the Commissioners, Mr. Hamerla, the time to be determined. Tim Madigan from the Lacrosse group will be invited to the site walk. Mr. Black requested that Mr. Hamerla submit a formal letter of request to do the project for the Commissioners approval. A motion and vote was taken to sign the preliminary proposal by Mr. Hamerla. The vote was unanimous for approval.
- Candidate Opening There are no candidates running for the vacancy on the Parks
  Commission. Three possibilities exist to fill it. There could be a write-in vote at the
  elections. If not, the Parks Commission and Selectmen could appoint someone or the
  Selectmen alone could appoint someone. Mr. Ohringer believes he knows someone
  who would be interested in being on the Commission.
- Hazel Grove Ms. Smigelski will compose a letter to the Lagasse Family regarding tree
  work to be done at Hazel Grove Park. She will bring it to the May meeting for approval
  to send. The West Tower is tipping and needs to be taken care of. This is a safety
  issue. The tower is not under any historic building regulations, so it could be demolished
  and rebuilt. A motion and vote was taken to approve Ms. Smigelski to bring forth a plan
  to demolish the building and disconnect the electrical. It was unanimously approved.

- Contracts were awarded to:
  - For Sanitation to A1 Portable Toilets at \$68/unit/month.
  - o For Fertilization to Aslan Enterprises for \$12,544.
  - For Landscaping the parks, commons, and the Hanson Playground to Block and Blade for \$3,932.50 plus a stone wall repair for \$45/linear foot.
  - Irrigation is still under warranty.
- Field of Dreams will be finished and used this year. It will be a game field and not a
  practice field.
- Mr. Ohringer will submit an application to the Board of Health for a permit to deepen the wash well at Cow Pond.
- Mr. Strauss will get estimates to fix the top rail fence at Cutler Field.
- Mr. Strauss proposed pursuing more money for the Parks budget because of Hazel
   Grove coming on board. It would be enough for reasonable upkeep and maintenance.
- Mr. Strauss proposed that a Vice Chairman be elected and to rotate the Chairman position each year. The Vice Chair would become Chair the following year.
- Ms. Smigelski said that softball is not using Cutler Field because of the infield.
  Discussion pursued and it was noted that people also don't want to travel from
  Dunstable to West Groton. Mr. Black said that the softball representatives need to come
  to a meeting and bring a plan of what they want and need.
- Community Preservation Committee wants to put a sign at the Field of Dreams designating that the field was funded by the CPC.

ADJOURN/NEXT MEETING: Mr. Black adjourned the meeting at 9:44pm. The next meeting will be held at the Legion Hall on Wednesday, May 9th at 7:00pm.
