## BOARD OF SELECTMEN MINUTES APRIL 7, 2008 APPROVED

Mr. Dillon called the regular meeting of the Board to Order at 7:00 p.m. and reviewed the agenda for the public.

# Susan Hogan, Dog Officer; George Moore, Animal Inspector; Tom Delaney, Animal Control Officer, RE: Job Descriptions & Individual Job Responsibilities

Mr. Dillon wanted to address some misperceptions with the public on the overlapping duties of the Animal Inspector, Animal Control Officer and the Dog Officer. The animal control officer is appointed by selectmen, while the Animal inspector is nominated by the selectmen but approved by the state. Mr. Delaney gave a brief history as to why there are three positions. Mr. Moore noted that a census has occurred to count the number of animals in Town. Mr. Moore outlined his duties as Animal Inspector and if calls come in he channels them to the proper people. Ms. Hogan is responsible for the Dog Pound and handles dog complaints that come in. Ms. Hogan also places dogs that need homes. The Selectmen thanked the animal officials in town for all of their hard work.

#### Tom Delaney, Highway Surveyor, RE: Sidewalk Plowing Report & Draft Policy

Mr. Delaney noted that there is a copy made for sidewalks through the GIS and indicated which sidewalks were town owned Mr. Delaney marked which sidewalks were plowed by the DPW. Mr. Delaney added that there has been requests to maintain more than what is currently being done by the Town. Mr. Keoseian noted the concern with children walking in the streets. There was a question as to whether subdivisions should be plowed. Mr. Delaney informed the Board of what equipment was available to the Town to clear the sidewalks.

## Donald Palma, Chief of Police, RE: Streetlights Report

Chief Palma noted that the listing of streetlights took longer and master lists were obtained from GELD. Chief Palma stated that there were 719 lights in total – 187 are privately paid for – 106 adopted lights, during previous budget issues people adopted and paid the expense. 45-50 removed; about 199 that could be considered as potential turnoffs. Chief Palma listed a cost savings 6.50 per month per light totaling 16k per year. The Board suggested wattage is looked into on certain streets. Chief Palma discussed streets that were illuminated very well and targeted areas that should not be as illuminated to save money. Chief Palma stated that he would continue to work with GELD.
