1. There is one item scheduled on Monday's Agenda. As requested by the Board, time has been set aside for the Board to determine whether or not the install the "All Are Welcome Markers" as approved by the 2017 Spring Town Meeting.
2. It is that time of the year for the Town Manager and Board of Selectmen to make their annual appointments/reappointments. Scheduled on Monday's agenda will be the Town Manager's annual appointments. Enclosed with this report is a listing of the appointments I plan on making effective July 1, 2017. As has been our history, I will read the names into the record so the public is aware of who is being appointed to what position. Pursuant to Section 4-2(c) of the Groton Charter, I would respectfully request that the Board consider ratifying these appointments at Monday's meeting. We will schedule the Board's annual appointments for your June 19th meeting.
3. As discussed with the Board at your last meeting, the Senior Center Building Committee held its first meeting this past week. Peter Cunningham was elected Chairman and John Amaral, Vice Chairman. The first meeting was spent discussing how to determine why the debt exclusion vote failed at the Annual Election and what needs to be done to successfully address the needs of our Seniors given limited tax dollars and a building that no longer serves the needs of the Council on Aging. The Committee will spend the next several months developing a new plan and strategy and will report to the Selectmen and Council on Aging periodically. The next meeting is scheduled for June 21st. I will continue to provide the Board with updates.
