### **ARTICLE 1: Prior Year Fiscal Bills**

### ARTICLE 23: Transfer a Sum of Money to the Stabilization Fund

For good financial management, it is recommended to have between 5% - 10% of the Town's operating budget in Stabilization Funds. Prior to this Town Meeting, the balance in Free Cash was approximately \$904,000.

### **ARTICLE 24: Offset the Tax Rate**

To see if the Town will vote to transfer a sum of money from the Excess and Deficiency Fund (Free Cash) or from other available funds for the purpose of affecting the tax rate for the period beginning July 1, 2006, and ending June 30, 2007, or take any action thereon.

**Summary:** The effect of this article is to use a portion of Free Cash remaining after this Town Meeting or other non-tax sources (e.g. the General Stabilization Fund) as a funding source for the total FY07 budget thus lowering the amount of money required to be raised from taxes. Prior to this Town Meeting, the balance in Free Cash was approximately \$904,00. The balance in the General Stabilization Fund was approximately \$1.1 million.

### **ARTICLE 25: Right to Farm Bylaw**

To see if the Town will vote to establish an agricultural commission to act as an advocate for and promote agriculture in the Town of Groton, and adopt a "Right to Farm Bylaw."

The members of this Commission would be appointed by the Selectmen and would act to promote and advocate for agriculture in the Town of Groton.
